GREGG TOWNSHIP SUPERVISORS JUNE 5, 2023 MEETING MINUTES

David Masser, Chairman, called the meeting to order at 4:30pm with the following in attendance: Mike Keiser, Vice Chairman; Arthur Masser, Supervisor; Doug Hovey, Zoning Officer; Brian Kerstetter, Solicitor; Daniel Vassallo, Engineer; Linda Masser, Resident; and Jodi Willow, Secretary/Treasurer.

The meeting started with the Pledge of Allegiance.

Old Business- Daniel Vassallo, the Engineer/Surveyor for the Lapp Subdivision, was present to discuss the Aaron Lapp turnaround. He recalls that they agreed to give the township an additional 50 ft right of way, but not that Mr. Lapp would have to build it. The township states that they asked for a built cul de sac because Mr. Lapp built a building and put a garden where they used to turn around. The plan was approved April 2022 and there is no note in the plans regarding building the turnaround.

David Masser, Chairman, closed the regular meeting at 4:50pm. He then opened the public hearing, as advertised in the Standard-Journal, for the adoption of Ordinance 2023-01, an amendment to the Zoning Ordinance. The solicitor asked for public comment. Hearing none, motion by Arthur Masser, second by David Masser to adopt Ordinance 2023-01, a zoning ordinance amendment adding single family dwelling as a conditional use in the commercial district. Unanimous. The public hearing was closed at 4:53. The regular meeting was reopened at 4:53pm.

Old Business- Mr. Lapp was not present to discuss if he was willing to build the turnaround. The township sent Mr. Lapp a letter in February and in response to that letter, he stated that he was willing to build it. The township requests that Mr. Lapp be present at the July meeting to discuss the turnaround.

New Business- After some discussion, motion by David Masser, second by Mike Keiser to add Lot 4 to the Letter of Credit for PNK in the total amount of \$4,384,804.93. Unanimous.

Motion by David Masser, second by Mike Keiser to approve the May 1st, May 5th and May 22nd meeting minutes, the financial report and the payment of bills. Unanimous.
